2021 was another tough year for everyone in our communities. The way you responded gives us all hope for a better tomorrow.

United Way has is committed to serving the community through triumphs and challenges. We remain committed to uniting the caring power of the community to help people in need. Here are some of our accomplishments from 2021, thanks to you:

**Big Moves in Childcare.** We are so much closer to removing the barrier of childcare for our working families. The Tri-Share Childcare pilot program was launched in Muskegon early in the year by Goodwill Industries. It has now extended to five surrounding counties. This program splits the costs of quality childcare between the family, their employer, and the state. The Y Early Learning Center was opened last June to serve infants through school-aged children to provide a safe and nurturing environment. This center is state of the art and has provided much-needed care to children in our area.

**Collection Drives.** Our community started strong last year, collecting the most coats we have ever seen in a single drive. More than 1,500 coats were distributed to our families in need. In the spring, baby products were collected for the annual community baby shower where 156 babies were supported with diapers and other essentials. During Stuff the Bus, our community showed incredible love and support for our local teachers by donating supplies.

**Community Outreach and Advocacy.** A new ALICE report launched in April and volunteers rallied to become ALICE Ambassadors. These volunteers took a critical deep dive into the demographics and disparities that are reflected in the report to help support our families through advocacy and outreach. Light Up the City continued to

strengthen the bonds between police forces and the Muskegon Heights Community while promoting safety in their neighborhoods. We continued our partnerships in career readiness to support growth for 100 youth.

**Crush COVID-19 Campaign.** The Muskegon COVID-19 Emergency Response Volunteers took action to support our local hospitals, nursing homes, and public health department with the newly launched vaccines in March. Over 200 volunteers supported our vaccination and testing efforts in some way. Volunteers called, transported, helped register, and educated our local community about COVID-19 vaccines.

**Pandemic Response and Recovery.** We continued our efforts to support nonprofit agencies with grants of support to meet needs. Hundreds of families were assisted with temporary housing needs due to COVID-19 and helped with more permanent housing. Mobile food pantries were provided to support the hunger needs in our communities. Over \$455,000 in Emergency Food and Shelter Funds were distributed to area agencies and churches that served thousands.

**Education.** The Dolly Parton Imagination Library program serves over 5000 children in our area by sending a book a month in the mail to children up to age 5. Muskegon expanded the opportunity for preschool for our littlest learners through the new PreK for All program launched in the late summer and supported by United Way and local businesses. STEM programming in afterschool programs in Whitehall, Montague, Muskegon Heights, and Orchard View received sustaining funding.

**Honoring Those Who Served.** Volunteers surrounded our fallen veterans with several memorial cleanups throughout the county. Cleaning the headstones of these veterans has become a favorite tradition for United Way. Thousands of individuals came out to support our veterans at the Heroes United Festival which featured

Veterans Day Parades in both Fremont and Muskegon and featured the Budweiser Clydesdales. Heroes United not only paid tribute to veterans and United Way but was the kickoff party that launched Mission United – a fund that supports veteran programs through local agencies.

**Program Funding.** Nonprofit agencies in Muskegon, Newaygo and Oceana counties were awarded more than \$1.4 million for programs that focus on building thriving communities through health, education, and financial stability. 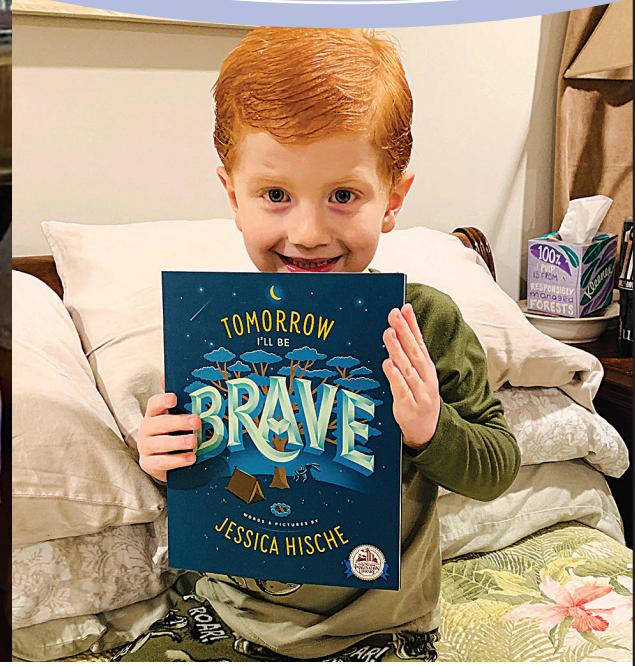
